The initial compulsory payment of \$1,600.00 is required to confirm your place and includes:

1. Residences' Building Maintenance Fund (RBMF) \$275.00 (non-refundable)
2. Communication Fee \$150.00 (non-refundable)
3. Academic Gown \$110.00 (purchase fee - 1st years only)
4. Payment towards the first four weeks of Trimester 1

Other charges not included in this schedule of fees are:

1. Annual DSRAC Fees, **paid separately** to the Drummond & Smith Residence's Association (1st Years \$170.00 & Returners \$130.00)
2. Other charges as listed in the college handbook are payable within 7 days of the invoice
3. Vacation accommodation may be booked by notifying the College Office prior to any vacation period (as per the 2012 Residential Principal dates). Additional vacation charges will be charged at the same daily rate.

Payment Options

1. **Full Year Payment** - full year total less initial compulsory payment of \$1,600.00 - due 5 March 2012.
2. **Monthly Instalments** - as shown above.
3. **Fortnightly Instalments** of \$518.000 - first fortnightly payment due by **5 March 2012**. Please refer to the fortnightly instalment due dates as listed below. (The fortnightly instalment option is not applicable for the initial compulsory payment of \$1,600.00).

Payments can be made by Bpay or POST Billpay – please ensure your payment is made at least 2 working days prior to the due date. Administrative fees will apply to outstanding accounts as per the Accommodation Agreement.
