TERMS

1. DEFINITIONS

Overseas Travel Notice means the notice annexed to this Agreement.

2. INDEMNITY AND RELEASES

In consideration of UNE's consent to the Overseas Travel, the UNE Student covenants with and promises to UNE that she or he will before, during and after in any matter or occurrence relating to the Overseas Travel:

- 2.1 Indemnify UNE from and against the full amount of all expenses, losses, damages and costs (on full indemnity basis and whether

incurred by or awarded against UNE) that UNE may sustain or incur as a result of the UNE Student undertaking or being involved in the Overseas Travel and the country of Overseas Travel whether directly or indirectly;

- 2.2 Not make any claim against UNE in respect of any medical expenses, personal injury or death or loss of or damage to property caused by or arising from any matter relating to the Overseas Travel;
- 2.3 Forever release and discharge UNE from all actions, proceedings, accounts, claims, demands, costs and expenses arising in any way of and incidental to the UNE Student undertaking the Overseas Travel.
3. Without affecting any other Term, the UNE Student must take all reasonable steps to minimize the possibility of the occurrence of any of the matters and things referred to including, without limitation, consulting the Government of Australia as to travel warnings and other risks in the country of the Overseas Travel.
4. The Details form part of this Deed.
5. This Deed is binding on the UNE Student's executors, administrators and assigns.
6. The UNE Student acknowledges that UNE has recommended that she or he obtain independent legal advice in relation to the Terms and consequences of executing this Deed, and acknowledges that she or he voluntarily enters into this Deed.
7. The UNE Student acknowledges that she or he has read and understood this Deed and warrants that she or he is over the age of 18 years (or if under 18 years that she or he will obtain the execution by the legal guardian of the UNE Student).
