Cl 15 (b) of the *Principal Dates Guidelines* provides that Council holds the authority to approve the Principal Dates of the University. The Executive Principal Education Futures is responsible for submission of the...Principal Dates to Academic Board (cl 19) for endorsement to Council for approval (cl 15.b).

Council will recall my previous advice (see CONFIRMED Council OPEN Minutes 28 January 2022 at Item 6.1 from p. 4) that an academic calendar bridging plan for 2023 is in place which sees a similar academic calendar—as that for 2022—be rolled over for 2023, given that the more advanced academic calendar revitalisation is not ready for implementation.

At its meeting of 21 February 2022, Academic Board endorsed the proposed 2023 Principal Dates (#AB22054). The Council is asked to APPROVE UNE 2023 Principal Dates #AB22053 (Attachment 1);

Amendment to the 2022 Principal Dates

Cl 15 (b) of the *Principal Dates Guidelines* provides that Council holds the authority to approve the Principal Dates of the University. Cl 17 of the *Guidelines* provides that under exceptional circumstances the University can change a Principal Date (but not a Statutory Date) after it has been published.

Amendment 1 re T3 2022 end-date

At its meeting of 21 February 2022, during discussion of the proposed 2023 Principal Dates (#AB22054), members raised an issue relating to a minimal break (one weekend) between the completion of Trimester 3 2022 and the commencement of Trimester 1 2023. This was identified as having a high likelihood of negative impact on staff and student workload, wellbeing, and progression.

Following consideration of options, Academic Board endorsed (#AB22064) that the 2022 Principal Dates be amended to allow a one-week break between Trimester 3 2022 and Trimester 1 2023 by reducing the Trimester 3 2022 end-of-trimester assessment period from 3 weeks to 2 weeks. This also impacts on Year-Long Period 2 2022 and Flexible Period B 2022, however, the impact is expected to be minimal.

The Council is asked to APPROVE amendment to the UNE 2022 Principal Dates #AB22064 re Trimester 3 2022 end-date (**Attachment 2**). This would amend the Trimester 3, Year Long Period 2, and Flexible Period B (2022) end date from 24 February 2023 to 17 February 2023.

Amendment 2 re additional Autumn graduation celebrations

As part of the University's decision (see Vice-Chancellor Communique dated 15 March 2022 – enclosed within **Attachment 3 – Updated**) to resume in-person graduation ceremonies and schedule additional graduation ceremonies, an amendment to the published 2022 Principal Dates is required to add additional Autumn Graduation celebrations:

Amendment 3 re amended T1 2022 Withdraw Without Academic Penalty Date

Following discussion by the COVID-19 Academic Response Team (CART) and endorsement by the Academic Board Standing Committee (via Flying Minute #ABSC22421 – see **Attachment 4**), the Vice-Chancellor (on 20 March 2022 via VCM22-03) approved amending the T1 2022 Withdraw Without Academic Penalty (WWAP) date from 02 May 2022 to 27 May 2022 to ensure that a students' academic record (including GPA) is not disadvantaged by COVID-19. Following consideration of Attachment 4, Council is asked to NOTE this amendment.

Academic Freedom and Code of Conduct

At its meeting of 21 February 2022, the Academic Board endorsed several recommendations made by the Academic Board Academic Freedom Working Group (#AB22062) in response to amendments proposed to the Code of Conduct ("COC"), Freedom of Speech Principles, and Academic Freedom Statement ("Principles/Statement") and the Freedom Of Speech and Academic Freedom Guidelines (Guidelines) (versions contained in #AB22056).

These recommendations were made in light, *inter alia* of the Walker (2020) and French (2019) reviews, and the previous recommendations made by the Working Group in #AB20086 and #AB20346, in addition to #AB21219, #AB21286, #AB21505, and #AB21510.

Recommendations that were endorsed relating to the policy amendments are as follows (#AB22062):

- That a mirror statement be provided in the Principles/Statement consistent with that in cl 17 of the proposed Code of Conduct and following similar wording to cl 4 Operations of the Model Code (UCC Version); and
- That the glossary definition for academic freedom reflects more closely the wording of Principle 2 and cl 11 and cl 12 of the Principles/Statement.

The glossary definition includes reference to the definition in the *Higher Education Support Act* 2003 (Cth) (Schedule 1 Dictionary), which is the same version as that in the UCC Model Code (Walker, 2020), and the UNE Principles/Statement. The latter provides support for academic freedom which is beyond compliance, i.e. is additional to (and not inconsistent with) the Model Code definition, and thereby also provides supplementary (and not contradictory) support for academic freedom. The UNE Principles/Statement in other words, 'goes further' and 'beyond compliance' to protect academic freedom (which is supported by the Walker (2020) review, see *inter alia* p 34). (see also discussion in #AB21505 and #AB22062).

Clarifications regarding intellectual freedom and academic freedom have also been progressed. These amendments, actions in response to recommendations endorsed by Academic Board, and Standing Committee (pending its meeting on 28 March 2022), appear in **Attachment 5**, for Council's approval and endorsement as detailed in the resolution above.

Course Withdrawal Policy and Process Amendments

At its meeting of 21 February 2022, the Academic Board endorsed (#AB22030) amendments to the Course and Unit Design and Approval Guidelines to remedy the gap in the process for notifying the Commonwealth re course withdrawals.

Under the funding agreement between the Commonwealth and UNE (under the Higher Education Support Act 2003), UNE is required to seek the Commonwealth's approval to withdraw certain Courses: "the Provider must consult the Commonwealth and obtain the Commonwealth's approval for the closure of the course" if the course: "prepares students for entry into any occupation that is experiencing a skills shortage" (cl 26.1), "would be likely to create a Skills Shortage" (cl 26.2), is a "specialised course directed at the regional economy" (cl 26.3), and or the course is "in areas of priority under the Job-Ready Graduates package" (cl 26.4).

Changes to the Course and Unit Design and Approval Guidelines and associated Course Suspension and Withdrawal workflows are required to action the Commonwealth's requirement. A new process has been implemented in the Curriculum Management System (CourseLoop) to ensure the Commonwealth's approval is sought in the required circumstances. This process requires the Academic Portfolio Executive Committee to confirm if a proposed course withdrawal needs the Commonwealth's approval and if so, arrange confirmation of the Government's support before the course is withdrawn. While the Government's support is being sought, the proposal can proceed through governance, however, the Vice-Chancellor's final approval cannot be provided until the Government's support is received.

This process change has required updates to the Course and Unit Design and Approval Guidelines (CAUDAG) and the associated Course Suspension and Withdrawal Workflow. Previously, the process for course suspension and withdrawal was the same but with these new changes, the workflows have been separated into a new Course Withdrawal Workflow and Course Suspension Workflow.

The Vice-Chancellor approved these amendments via VC Memo (VCM22-02) on 21 March 2022. A copy of this Memo and ancillary documents are provided in the Convene Document Library (Attachment 8) for information.

Third-Party Arrangements

At its meeting of 21 February 2022, the Academic Board #AB22046 received the closeout report on one of its third-party arrangements, with Monarch Institute, for the Bachelor of Commerce (Financial Planning) (BCOMFP) and the matter of outstanding accreditation with the Financial Advisers Standards and Ethics Authority (FASEA).

In addition to course level quality assurance, suspending enrolments into the course while the outcome was uncertain, and managing the existing students' experience on an individual basis the University has also undertaken:

- 1) An immediate review of the Third-Party Education Agreement Provider guidelines, was undertaken and published in the UNE Policy Register in November 2021.
 - i) This review incorporated improvements arising from benchmarking, current experience with third parties, including Monarch;
- 2) A review of the Monarch arrangement was made against the guidelines, and the Faculty is to provide an implementation plan by the end of Q1 2022.

- 3) A working party of the Academic Board was established to monitor the implementation actions relating to broader third-party agreements including Monarch, and
- 4) Establishing annual Academic Quality Assurance Reviews for third-party agreements.

Graduation Rule, Guidelines, and Certification

In light of the decision to resume graduations in April 2022, the Deputy Vice-Chancellor convened a Graduations Working Group (proposed to be provided for by clause (25) of the Graduation Guidelines) in February 2022. The Working Group has focused on two principal topics:

- ensuring that the processes for determining the eligibility of students to graduate (and thus the contents of graduation lists) are operating effectively
- overseeing the arrangements for graduation ceremonies.

The Graduation Guidelines recognise the potential for the University to engage a commercial provider of services related to the graduation ceremony event, at the same time acknowledging that the University retains responsibility for all activities related to graduation, including the graduation ceremony event. The proposed amendments to the clause (23) of the Graduations Guidelines are intended to facilitate engagement of a commercial service provider while retaining clear responsibility with the University. The Guidelines, therefore, include provision for the role of Graduation Officer to coordinate all activities related to graduation, including the graduation ceremony event. It is not intended that the Graduation Officer carries out all functions, but this role should be accountable for all tasks related to the graduation process.

Changes to the Graduation Rule have moved to a more direct, inclusive language, and the realignment between Rule and Guidelines where necessary. There are no substantive changes in these proposed amendments (see **Attachment 6 – Updated**).

Human Research Ethics Committee Terms of Reference

At the Research Committee meeting held 17 March 2022, the Committee considered a report from the Chair of Human Research Ethics Committee seeking endorsement to Academic Board (Standing Committee) and Council of revised Terms of Reference. These Terms of Reference were updated In late 2021 and underwent a full review and revision to meet external requirements set out in the National Statement on Ethical Conduct in Human Research 2007 (Updated 2018). Moreover, these Terms of Reference have been updated to meet current University standards, and following Council Approval will be added to the UNE Policy Register Database. A copy of these Terms of Reference is provided in Attachment 7 to this report. Subject to Academic Board Standing Committee endorsement (28 March 2022) Council is asked to APPROVE the revised Human Research Ethics Committee Terms of Reference.

Schedule 4 of the Amendment Act extends the regulatory regime for non- university higher education providers within the Provider Integrity Act to all higher education providers and provides additional circumstances in which a person is not a Commonwealth supported student, these amendments require that students be assessed as 'academically suited', by any requirements in the Higher Education Provider Guidelines, before a provider enrols them in a unit of study.

Academic Calendar

As flagged to the December 2021 Academic Board meeting (#AB21297), UNE has engaged an external contractor to conduct further analysis of the risks and impacts (business and financial) of the proposed model and to provide advice on any recommend treatments.

KPMG was the successful contractor and commenced in mid-December. A report is due to UNE in late February / early March and further decisions relating to a new academic calendar will be considered following receipt and evaluation of the report.

Principal Dates

Introduction

Each year UNE publishes principal dates covering the dates of teaching periods, examinations period and graduation days (amongst others).

As advised to Academic Board and Teaching and Learning Committee previously, while normally dates for each year are approved and published 20 months in advance, the 2023 Principal Dates were delayed due to the current consideration around a new academic calendar for 2023.

However, as noted above, KPMG is currently conducting further work on the calendar and therefore a decision relating to a new calendar is not expected until after provision and consideration of KPMG's advice.

Accordingly, given the lengthy work involved in preparing and finalising principal dates and the need to provide guidance to staff and students for 2023, Education Futures has prepared the 2023 Principal Dates based on the current academic calendar and the Principal Dates Guidelines.

Consultation

In December 2021, the draft dates were provided to key implementation areas across UNE for feedback. Feedback received was used to update the dates for formal consultation in accordance with clause 15 of the Principal Dates Guidelines. Academic Board and Teaching and Learning Committee members were also invited (via the Secretariat) to provide feedback.

Some changes to the draft dates were made in response to feedback received. A register of comments received and the responses is at <u>Attachment 2</u>.

The 2023 Principal Dates (<u>Attachment 1</u>) are provided for Academic Board's consideration and endorsement. Subject to the Board's endorsement, the Dates will be provided to Council for approval.

Key Information

Issue

The 2023 Principal Dates were provided to the 21 February 2022 Academic Board meeting for endorsement (see report #AB22054 – **Attachment 2**). At the meeting, members raised an issue between the published 2022 Principal Dates and the proposed 2023 Principal Dates as there is only weekend between the completion of Trimester 2 2022 and the commencement of Trimester 1 2023.

This short break has a negative impact on both staff and students. For students, there is a minimal break between trimesters, contributing to feelings of burnout and potentially impeding progression. Students would also not receive their results before the commencement of Trimester 1 which may impact enrolments and the student experience.

For staff, there is significant pressure to finalise marking, complete Board of Examiners meetings and release results in very tight timeframes, while at the same time preparing for the next trimester. This has a negative impact on staff workload and wellbeing.

After receiving this feedback, Education Futures explored potential options for addressing this issue and sought feedback from the Deputy Vice-Chancellor, Chair Academic Board, Deans and Associate Deans Teaching and Learning.

Following consideration of the responses received, Education Futures recommends the following amendments to the published 2022 Principal Dates:

- Amend the published 2022 Principal Dates to reduce the Trimester 3 2022 end-of trimester assessment period from 3 weeks to 2 weeks. This will allow a one-week break between Trimester 3 2022 and Trimester 1 2023.
- Amend the published 2022 Principal Dates to reduce the Year Long Period 2 2022 end-of trimester assessment period from 3 weeks to 2 weeks.
- Amend the published 2022 Principal Dates to reduce the Flexible Period B 2022 end-of trimester assessment period from 2 weeks to 1 weeks.

While a one-week break between trimesters is still not ideal, this will align this break with the standard one week break between trimesters.

Rationale

The 2022 Principal Dates were approved by Council in May 2020 and were subsequently published on the UNE website. The Principal Dates Guidelines (which govern the development and approval process of principal dates) state that published principal dates can only be changed in "exceptional circumstances". However, Education Futures considers that the negative impacts of the one weekend gap between trimesters for staff and student workload, wellbeing and progression should be sufficient reason for amending the dates.

The reduction in assessment weeks for Trimester 3 2022 from 3 to 2 weeks will bring the 2022 calendar in line with both current practice (T3 2021 and T3 2023 have a two-week assessment period) and the Principal Dates Guidelines which state that Trimester 3 includes a 2 week end of session assessment period. It will also likely have a benefit for workload and progression as it allows additional timing for marking, results finalisation and release, and preparation for Trimester 1.

The impact of this change is likely to be minimal as most current Trimester 3 units are based on an 11 week teaching and 2 week assessment period (per the 2021 calendar). While non-examination assessments for Trimester 3 2022 are yet to be finalised, it is expected that the due dates for these assessments could easily be accommodated within a 2 week period as this is the current practice. For examinations, there are currently 78 units with examinations scheduled for Trimester 3 2022. Once duplicates are removed (i.e. 300 and 500 versions of same unit), there are 63 units with exams. These could easily be accommodated within a two-week period as in the most recent Trimester 3 assessment period (2021), the examination timetable required only 8 days.

The impact of the change on Year Long Period 2 and Flexible Period B is also likely to be minimal. There are 39 units in these 2 periods, but based on 2021 data, this would only impact 12 students and assessment will be able to be completed in the reduced weeks.

Recommendation/Action

The amendments to the published 2022 Principal Dates (**Attachment 1**) is provided for Academic Board's consideration and endorsement. Subject to the Board's endorsement, the amended dates will be provided to Council for approval.

As flagged to the December 2021 Academic Board meeting (#AB21297), UNE has engaged an external contractor to conduct further analysis of the risks and impacts (business and financial) of the proposed model and to provide advice on any recommend treatments.

KPMG was the successful contractor and commenced in mid-December. A report is due to UNE in late February / early March and further decisions relating to a new academic calendar will be considered following receipt and evaluation of the report.

Principal Dates

Introduction

Each year UNE publishes principal dates covering the dates of teaching periods, examinations period and graduation days (amongst others).

As advised to Academic Board and Teaching and Learning Committee previously, while normally dates for each year are approved and published 20 months in advance, the 2023 Principal Dates were delayed due to the current consideration around a new academic calendar for 2023.

However, as noted above, KPMG is currently conducting further work on the calendar and therefore a decision relating to a new calendar is not expected until after provision and consideration of KPMG's advice.

Accordingly, given the lengthy work involved in preparing and finalising principal dates and the need to provide guidance to staff and students for 2023, Education Futures has prepared the 2023 Principal Dates based on the current academic calendar and the Principal Dates Guidelines.

Consultation

In December 2021, the draft dates were provided to key implementation areas across UNE for feedback. Feedback received was used to update the dates for formal consultation in accordance with clause 15 of the Principal Dates Guidelines. Academic Board and Teaching and Learning Committee members were also invited (via the Secretariat) to provide feedback.

Some changes to the draft dates were made in response to feedback received. A register of comments received and the responses is at <u>Attachment 2</u>.

The 2023 Principal Dates (<u>Attachment 1</u>) are provided for Academic Board's consideration and endorsement. Subject to the Board's endorsement, the Dates will be provided to Council for approval.

Executive Summary

In the context of supporting student success, particularly in challenging contexts such as the ongoing obstacles posed by COVID-19, UNE is proposing to offer a Student Support Package in Trimester One 2022. The introduction of Job Ready Graduate Legislation further increases the importance of precise language and supports for Future Fit Personalised Learning Journeys.

Appropriate communications to disseminate the Trimester 1, 2022 Student Support Package will be developed for both staff and students, utilising previously established CART communication development protocols.

Key Information

The COVID-19 Academic Response Team (CART) met on Monday 17 January 2022 and again Tuesday 22 February 2022 to consider student support options for Trimester 1 2022. During this discussion CART Members considered the need for appropriate practices and extensions of student support as contextualised to the needs of local, domestic, and international student cohorts.

At the 17 January meeting, CART Members noted that the University community must be mindful of the need for students and staff to feel supported, comfortable, and confident for Trimester 1 teaching and learning activities. CART Members agreed that from 01 December 2021 the University had returned to approved modality of unit offerings in accordance with the UNE COVID-Safe Plan and individual circumstances:

- whilst remaining pro-active to stop the spread of COVID-19, the University is also managing the inevitability of responding to increased confirmed cases and notifying staff/students via various means.
- some staff/students may not be able to return to in-person activities due to medical considerations, however, these will be accommodated on a case-by case-bases where possible (notwithstanding any accreditation requirements).

Members also noted the need for the University to remain agile, to make quick, responsive changes, based on principles and guidelines, should the need arise. An overview of the background information, proposal principles, and guidance are provided below.

The Academic Board Standing Committee considered - and endorsed - several proposals throughout 2020 and 2021 (see #AB20288, #ABSC21419, and #ABSC21434). As an action arising from the CART meeting on 17 January 2022, the Executive Principal Student Experience was tasked with leading and moderating consultation to derive appropriate recommendations for endorsement pursuant to the CART Terms of Reference and General Rules.

Background

With a number of units scheduled for on-campus delivery and mandatory on-campus learning activities in Trimester 1, 2022, it is critically important that UNE establish a set of support mechanisms to support students in undertaking their learning activities and/or mandatory on-campus activities which may be impacted due to COVID-19 restrictions or otherwise.

Student Support Package

To ensure a student's academic record (including GPA) is not disadvantaged, authorised 'Student Experience' staff (delegated under the authority of the Executive Principal Student Experience) will be able to implement the following agreed actions for the finalisation of grades for students enrolled in 2022:

- students who demonstrate an impact to their studies based on the criteria* will be eligible to apply to:
 - i. continue to withdraw without academic penalty after the specified Principal Dates 2022 until the last day of the Teaching Period;
 - ii. convert a Fail (N), Fail Incomplete (NI), or Fail Compulsory Assessment (NC) grade to a Withdrawn (W) grade, ; and
 - iii. convert a passing grade (P), (C), or (D) to "Satisfied Requirements" (SR)**
 - ** where appropriate; limited in certain accredited courses.

*Criteria (based on #AB21419) Student Support Package 2022:

This includes those who have:

- contracted COVID-19.
- increased carer commitments for family members resulting from COVID-19 diagnosis,
- mandated self-isolation,
- transitioned from on-campus to online learning,
- been required to relocate from their usual study location or have circumstances that impact their study (e.g., home schooling, caring for children requirements) as a result of COVID-19 restrictions,
- employment in an essential industry and have experienced increased or a change in work commitments due to COVID-19,
- lost employment and needed to seek alternate employment or apply for government subsidies (this includes self-employed and affected business owners).

At the CART Meeting held on 22 February 2022, Members noted that previous student support packages allowed for student(s) to apply to their Unit Coordinators and Board of Examiners to seek WWAP or a grade conversion (pending evidence of impact), however, that this process was being undertaken centrally and should be reflected accordingly within the student support package. Members noted that, as indicated within the caveats of the support package, that these options would be limited in certain circumstances such as for externally accredited courses inter alia.

<u>Higher Education Support Amendment</u> (Job-Ready Graduates and Supporting Regional and Remote Students) Act 2020

On 07 October 2021 CART Members discussed changes to the Higher Education Support Act arising from the Jobs Ready Graduates amendment (see below). Following the CART meeting, the Director Education Quality noted that the legislation does allow for exemption in special circumstances and requested that, given the implementation of this requirement is being led by Student Experience, the Executive Principal be asked to confirm implications for students if the student support package is extended.

At the following meeting of the CART held on 12 October 2021, the previous, Head Student Transformation, Mr Simon Stubbs informed Members that the implementation of the above outlined clauses would only apply to those students commencing in T1 2022, however, that consideration would need to be given to such provisions under any future support packages. Mr Stubbs informed CART that the Student Experience Directorate were assessing the legislative requirements and that more information would be forthcoming.

Specific application of the Job Ready Graduates legislation to UNE policies, guidelines and practices, and accompanying communications requires further consultation and will be addressed in a separate document.

Key Information

Amendments to the Code of Conduct, Freedom of Speech Principles and Academic Freedom Statement, and Freedom of Speech and Academic Freedom Guidelines endorsed by the Academic Board at the 21 February 2022 meeting, and incorporated into the proposed policies are summarised below:

Glossary definitions

Academic Freedom has been amended to include the definition legislated in Higher Education Support Act (2003), and the proposed amendment includes reference to the Freedom of Speech Principles and Academic Freedom Statement recognising that Academic freedom is a composite principle, as stated in the Freedom of Speech Principles and Academic Freedom Statement at Principle 2, and in Clauses 10 and 11.

Intellectual freedom definition is amended to indicate that Intellectual freedom has a meaning corresponding with academic freedom.

Freedom of Speech and Academic Freedom Statement addition of Clause 20 To the extent of any inconsistency with any non-statutory policy or rules of the University, including the Code of Conduct, this Statement prevails, mirroring Clause 17 of the Code of Conduct. *Please note that both of these Clauses are under review with UNE Legal Services*.

References to the Academic and ELC Staff, and Professional Staff Enterprise Agreements have been updated to correctly reflect wording from the Agreements, that is to indicate the agreements recognises and supports intellectual freedom for staff (Clause 18 of the Statement, Clause 14 of the Guidelines). It was noted at Academic Board that these Clauses previously incorrectly stated 'academic freedom' instead of the intellectual freedom. This revision corrects an error in the previous Clauses.
