

Right of Access to Thesis

This agreement covers two issues relating to copyright and your thesis:

- Part A: as the author of your thesis, you are required to indicate that the work is your own and you have not infringed copyright in materials created or owned by others;
- Part B: as the author of your thesis, you are required to decide whether you wish to allow others to access all or part of your thesis through the University Library and e-publications@UNE, the University's open access institutional repository.

Part A: Use of copyright materials created or owned by others

- 1.1. You are responsible for ensuring that the Thesis does not infringe copyright in materials created or owned by others. If you have included the work of others in the Thesis, you should record all of the information regarding your copyright clearances in a separate table headed ‘Copyright Compliance Table’ and append it to the Thesis.
- 1.2. Where copyright clearances have not been secured, or the University becomes aware of infringing material in the Thesis, the University will cease to provide open access to the full version of the Thesis, but information about the Thesis (e.g. abstract and bibliographic citation) may still be accessible from e-publications@UNE.

Part B: Access Conditions

- 2.1 This agreement does not transfer copyright ownership of the Thesis to the University, so you retain the right to make use of current and future versions of the Thesis elsewhere.
- 2.2 As the Author of the Thesis, you have the moral right of attribution. The University agrees to clearly identify the title and author of the Thesis in accordance with this right.
- 2.3 The level of access you provide to the Thesis will depend on your individual circumstances. The examples given in the table below are examples only and not a list of all possible situations. If you initially elect to make the Thesis available by open access, you still have the option of later restricting access to the Thesis by following the procedures below.

If this is the case, some information about the Thesis (e.g. bibliographic citation) may still be accessible from e-publications@UNE.</p> <p>The Thesis may be used by others for the purposes of research or study, as allowed under section 51(2) of the <i>Copyright Act 1968</i> (Cth).</p>	<p>You wish to make the Thesis available worldwide as soon as possible.</p>
<p>Restricted Access</p> <div style="border: 1px solid black; width: 40px; height: 40px; margin: 10px auto;"></div> <p>Thesis to be restricted for _____ years from the conferral of the degree.</p>	<p>The Thesis will not be made available for worldwide open access for the period of time you nominate.</p> <p>You are required to complete and submit the 'Request to Restrict Access to Thesis' Form on an A4 page to support the restriction. Where possible, information about the Thesis (e.g. abstract and bibliographic citation) may still be accessible from e-publications@UNE and the UNE Library.</p> <p>The restrictions may be lifted or adjusted by you upon written request to the University Librarian and Head of School.</p> <p>Once the period of restricted access has passed, the Thesis will be made available for worldwide open access.</p>	<p>Ethical reasons, for example, where personal or other information is disclosed in the Thesis.</p> <p>You have entered into contractual arrangements that prevent you from making the Thesis available by open access.</p> <p>A publisher places conditions on publication of the Thesis relating to open access.</p> <p>The Thesis has commercial potential that might be damaged by free open access.</p>

- 2.4 By signing this agreement, you grant the University permission to do what is necessary for the preservation of the Thesis.
- 2.5 The deposit and management of the Thesis is subject to the e-publications@UNE Deposit, Collection and Access Policy.
