In November 2014, 28 UNE Business School students took part in the China Study Tour.

On behalf of the UNE Business School I would like to thank everyone who made the China Study Tour a success, particularly to Dr Lou Conway, Dr Tony Ramsay and John Schuman for their hard work.

### **UNEBS China Study Tour**

No amount of time in the lecture theatre could have conveyed the understanding of China that 28 UNE Business School students acquired in 12 packed days in the Peoples' Republic during November 2014.

The tour was conceived as an "immersion experience", to introduce students to the cultural and business environment of the nation that promises to be the global economic powerhouse of the 21st Century. The program was broad in every sense.

The students came from courses across the School and from origins that ranged from Tasmania to outback Queensland. Many were studying from home, only to meet other students for the first time in the departure lounge of Sydney Airport. For many, it was their first trip overseas.

The schedule, developed by Dr Conway and Dr Ramsay, took students behind the scenes in three areas: agriculture, manufacturing and finance.

Students sat in on numerous briefings including the Australian Embassy in Beijing, National Australia Bank in Shanghai, and Jardines and Citi in Hong Kong. They visited a vertically-integrated cattle feedlot, a 5000-cow Australian-developed dairy, a GM car factory and a

suburb-sized vegetable greenhouse. For two days, they immersed themselves with specially assigned students from the Shandong Institute of Business and Technology (SDIBT) where they learned about the high aspirations of fellow students of their own generation.

Our students saw the astonishing wealth that has gravitated to the centres of Tier One Chinese cities like Beijing, Shanghai and Hong Kong. They received a first-hand appreciation of the fact that China will, in the not too distinct future, acquire the biggest economy in the world.

To balance the displays of economic wealth, the students were also introduced to a working-class Shanghai suburb, one of the first suburban development projects of the Communist government in the 1950s. They ate with retired factory workers in their tiny apartments, and walked through the sometimes disturbing variety of an inner-city "wet" food market. They walked along the Great Wall, posed in front of Chairman Mao's portrait in Tiananmen Square, visited an ancient temple built on the birthplace of Confucius, and spent three hours travelling 800 km on China's 15,000 km High Speed Rail network.

As the impressions piled up, the students' thinking began to change. They began to understand the nuances of the "one country, two systems" project, where unbridled capitalism flourishes under a centralised administrative government authority. For some, a revelation was seeing the innumerable small meaningless jobs performed by poorer Chinese - and coming to understand that rather than inefficiency, as they first thought, these apparently insignificant roles provided the dignity of employment and social esprit de corps.


All were taken aback by the pollution. That led to some sober consideration of the implications of economic growth at all costs.

Most importantly, the students stopped seeing China as a bundle of dry statistics and began to see it through the lens of Chinese society. It would be safe to say that no-one returned unchanged - not just in their views about China and its new status as an economic powerhouse, but in their perceptions of Australia and its ability to engage with China. Finally, upon return from China, students provided written academic work that was shaped and informed by their first hand experiences.

The 2015 tour is already being developed (see OSSE300 Overseas Study Experience in the UNE Unit Catalogue).

The School would urge anyone with promising students with a keen curiosity and a desire to better understand the "Asian Century", to bring them forward as candidates. It is the best kind of education that will not leave your students unchanged.

Head of the UNE Business School, A/Prof Martin Hovey, along with members of his staff, welcomed our Chinese guests to UNE to discuss the undergraduate cooperative education program and exciting prospects for joint research and education relations with HAU. UNE Acting Pro Vice-Chancellor, Gabrielle Rolan and Acting Director of UNE International, Ingrid Elliston met with the delegates to review the HAU Study Abroad Program agreement and develop future initiatives. Our guests also discussed sustainability, environmental and precision agricultural research developments and collaborative opportunities with Prof Iain Young, the UNE Head of the School of Environmental and Rural Science.

HAU was founded over 110 years ago, and is located in east-central China, situated in the capital Zhengzhou of the Henan Province. Zhengzhou is one of the Eight Great Ancient Capitals of China and an emerging megacity of China. HAU have over 30,000 full-time on campus students with 10 different fields of study available including Agriculture, Engineering, Science, Economics, Management, Law, Humanities, Medicine, Education and Arts. The university is equipped with 20 colleges, 29 research centres and has over 1875 full-time staff members. The number of professional affiliations with the Ministry of Agriculture in different research fields highlights HAU collaboration and expertise in Agriculture exploration.

The exciting and tangible outcomes generated by this delegation's visit to UNE points to another positive step forward for this collaborative partnership. # UNE Business School's students tackling the world and becoming the solution

In June, a team of four University of New England students will compete in an Agribusiness Case Study Competition in the USA at the 2015 International Food and Agribusiness Management Association (IFAMA) 25th Annual World Symposium and Forum.

During the conference, the team will be one of 20 from around the world competing for the international title. They will draw on their Agribusiness and Agricultural and Resource Economics knowledge and skills, particularly in relation to Food and Agribusiness Management. Students will also meet and network with leading global agribusiness executives, researchers and government officials.

The conference theme is "Becoming the Solution" focusing on Innovation, Talent, and Technology in the 21st Century of Agribusiness. This will be a key discussion point for change makers at the conference. It will widen the students' perspectives for contributions to Australian and World Agribusiness.

UNE Business School's Prof Derek Baker and Dr Stuart Mounter, who are engaged in the selection process and will accompany the team, said "this puts our students on the map internationally and such international experience is a key part of engagement with the local and international agribusiness communities. Working with Rimfire Resources, a specialist agribusiness recruitment agency, is allowing us insight into the large growing job market in Agribusiness and Agricultural and Resource Economics. We are very grateful to Rimfire Resources and Grain Growers for their significant financial support they have offered to students who take part in the conference and competition."

Head of UNE Business School, A/Prof Martin Hovey concurs, "this opportunity will provide the ideal global setting for students to apply their studies to real life situations and they may identify career opportunities that they may not have otherwise considered possible."

# Remote Town Survival Guide: Cheap Housing and Diversification

Mr Stuart Robertson, PhD student and Dr Boyd Blackwell, Research Fellow with the Business School have been attracting media attention to their research with the help of the UNE and NintiOne Ltd communication teams. Stuart's project on mine lifecycle planning and enduring community value for remote towns has received considerable media attention over the Christmas break as a result. Their published work in the International Journal of Rural Law and Policy and the joint UNE & CRC REP media release have been centrepiece for attracting this attention. Stuart has had interviews with ABC Broken Hill NSW on 8 January 2015, ABC Capricornia and ABC Country Hour Qld on 19 December 2014. Boyd had an interview with ABC Drive NSW on 19 January 2015.

Their initial findings show that companies, government and community groups need to plan early for diversifying the base of their economies leading up to a resource development and throughout the life of the mine, and resource towns should be 'open' to all people rather than 'closed' to mine workers. Ways to create enduring value for remote communities from mining include appropriate investment of mining royalties, development of employment opportunities and regional partnerships, and much needed investment in built and social infrastructure such as transport and communication networks including roads and airports, community centres, pools and other sports facilities, libraries, arts, crafts and museums, and meeting, music and performance places. These 'diversifying' investments can help make these remote locations attractive to live in and visit, and people are a key ingredient to broadening the economic base of a town. As you know, we have adopted a new theme in our Moodle sites from Trimester 3 and upgraded our version of Moodle to version 2.7. Training sessions have been hosted in the School regarding the changes in managing your sites in terms of adopting the theme and upgrading to Moodle 2.7. If you are teaching in Trimester I and were unable to make a training session in

the past and would like one-on-one training, please don't hesitate to contact a member of the EDC Team to organise a time.

As UNE introduces Echo360 as our lecture capture application TaLS and ITD will be holding a series of information sessions across campus along with IT Training hands-on workshops. From Trimester 1 2015 onwards Camtasia Relay will no longer be supported or accessible for staff wishing to record their lectures.

If you are intending to record your lecture presentations during Trimester I 2015, please attend one of the provided Echo360 information training sessions as scheduled below. These training sessions will provide you with all the skills necessary for getting started with Echo360.

Staff wishing to record with Echo360 in Trimester I 2015 will need to fill out the ServiceNow form. This is the same information that was required for booking in a Camtasia Relay profile, however the process is now setup through Service Now. Once a staff member fills out, and submits this form, a request will be sent to me with the booking information. I will then notify staff once they have been booked in for using Echo360.

When a staff member attends one of the required training sessions as below. They will be given a hand out that will include the profile booking information as above, ESS information including Personal Capture download, and links to online resources. There will also be a handout with copyright for lecture capture information, and some capture processes. I will also run through a basic "getting started" demonstration for capturing with Echo360.
