The new academic year has begun, and we are now aligned across our teaching periods for both our undergraduate and postgraduate programs. This shift is something we have been planning for over the past twelve months and has prompted us to look more closely at our administrative processes within the School, including the management of our teaching materials through our learning management systems. As part of this process, it came to my attention that there were some variations in how units were being presented online. While academic staff make the final decision on what functions their units include, there are some basic functions which must be common to all units, and which should be presented in the same order. In ensuring consistency across units, the educational development team have identified the features available and used by staff, and we have agreed on the order in which they will laid out in the online space. Your feedback on this will be welcome as we seek to improve the look and feel of our units for students.

From the 15-17 February, Rene Villano and I visited Penn State University to set in place cross-institutional arrangements for students in their Master of Professional Studies (Community and Economic Development) and our Master of Economic and Regional Development. This trip was funded through the Vice Chancellor's Strategic Funds, which we were allocated in 2010 for the purpose of revitalizing postgraduate economics and undergraduate agricultural economics programs. While we were at Penn State, we agreed on the cross-institutional arrangements at the postgraduate level, and also explored opportunities for exchange programs within our undergraduate agribusiness and agricultural and resource economics awards. We will need to do more work to progress the exchange opportunities for the undergraduate programs, and are excited about the prospects for internationalizing our curricula in this way.

## Welcome Boyd Blackwell

Boyd joins the School as a Postdoctoral Research Fellow, Enduring Community Value from Mining. His five year project is jointly funded by UNE and the Cooperative Research Centre for Remote Economic Participation, part of NintiOne in Alice Springs. Boyd is supervised by Professor Brian Dollery, BEPP and Professor Fiona Haslam McKenzie, CRC REP Team Leader, from Curtin University. Boyd's case study site is the Tanami mine in NT. He will be interviewing mine workers about their expenditure patterns and socio-economic characteristics to build an input output model of the local economy. The model will be used to assess the economic impact of the mine on local remote communities. Comparator sites will also be used and he will map the flow of income through the economy. The project will help inform policy decisions about creating enduring value to remote communities from mining.

Boyd comes to the School with a background in natural resource, environmental and ecological economics with a strong research interest in non-market valuation. He has previously worked in the following organisations:

- Lecturer, National Centre for Marine Conservation and Resource Sustainability, Australian Maritime College, University of Tasmania, in Victoria and Tasmania 2006-2010
- Various roles with Water Reform, Urban Water Policy Development, Office of Energy and Cooperative Research Centre for Coastal Zone, Estuary and Waterway Management with the Queensland Government, Brisbane 2001-2005
- Heritage Icon Value Project, International Centre for Ecotourism Research, Griffith University, Gold Coast
- Research Economist, Minerals Economics Section, Australian Bureau of Agricultural and Resource Economics, Canberra

## Ideas to Action (i2A) Centre

Following a great deal of background preparation, the Faculty of The Professions i2A Centre launch occurred on August 18<sup>th</sup> 2011. Following the Faculty funding approval, Philip Thomas was successful in securing the position of Director, which began on the February 13<sup>th</sup> 2012. There is also an appointed Advisory Board in place for the i2A Centre. Members of the Board include Mr John Keniry (Chair), Mr Raj Verma, Mr Mike Logan, Professor Alison Sheridan, Professor Ted Alter and Professor Paul Martin.

In line with the newly released UNE strategy, which refers to UNE's role in leading rural innovation, the focus of the i2A Centre is on the development of research within innovation and entrepreneurship. The emphasis is on shared learning and scholarly exchange to establish a base of engagement within domestic and international research collaborations that will involve industry and community.

Activities of the i2A Centre include the recently completed NSW Government Enterprising Regions Program project *Strategic Development Community Based Innovation in the Northern Inland Region of NSW.* It is now revealed that partner support for work resulted in a 6 month project of over 200K, with 90K of that provided by the NSW Government. With our Penn State partners, ongoing research development opportunities arising out of this project are currently being explored.

In addition, the policy and institutions component of the extension bid of the Invasive Animals CRC, led by Paul Martin, focuses on enabling community led action within the research. Professor Alter (PENN State) is leading the component on community engagement and it is anticipated this community engagement research program will feed into the i2A Centre and significantly contribute as a demonstration of the Centre's focus.

Within his new position Philip Thomas is also Course Coordinator of the Professional Doctorate Industry and Professions (ProfDIP). This HDR currently has a cohort of 25 candidates and has a constant flow of enquiries from interested prospective candidates. The portfolios currently being developed around the innovation projects of the candidates cover a diverse range of subjects and including product and process innovation. For example:

Environmental industrial/community policy adaptation:

Climate change and community and industry strategies and response.

Institutional change management:

 Policing and community engagement review responses (involving a cohort from the WA Police Academy).

#### Health:

- Development of a bone densitometry reporting tool for paediatric use.
- Social inclusion in health service delivery (prospective).

The first graduation from the ProfDIP is expected in 2012. In light of the suite of projects now running and those currently being considered in applications for candidature, it is anticipated that the resultant research engagement and networking with industry, community and academia, will continue to develop and expand. These interactions will provide fertile ground for the development of ongoing research strands that will assist in building the profile of the i2A Centre and help support the Centre's existence and operations.

The immediate challenges now include developing resource support for operations, creating and promoting the identity of the Centre and further developing the links to relevant organisations and research groups, within active research partnerships.

## **BEPP Conference Travel Grant Reports**

Successful conference travel grant recipients report on their recent conference attendances.

#### **Professor Larry Smith**

The 10th Hawaii International Education Conference was held in Honolulu from 5-8 January 2012. The conference was organised around four major themes (early childhood and primary schooling; secondary schooling; technical education; and higher education), with each day comprising a major presentation followed by a series of paper presentations. Over 400 people participated in the higher education theme area, with academics coming from over 20 countries. Topics ranged from governance/policy/strategy issues to teaching and learning processes and demonstrations of the latest technologies. My paper was titled: "International approaches to the recognition of non-formal and informal learning for access to university awards", and was based on an analysis of the OECD country background papers. 109 people attended my paper session. The major benefit of the conference was in the expansion of professional networks, and in particular, the interaction with academics from non-traditional university locations (such as Newfoundland, Equador, and Iceland). I am happy to provide a copy of my paper to anyone who is interested. A full set of conference proceedings is currently being published.

#### **Australian Agricultural and Resource Economics Conference**

BEPP was very well represented at the 56<sup>th</sup> Australian Agricultural and Resource Economics Conference in Freemantle, WA. with *Bligh Grant*, *Professor Oscar Cacho*, *Dr Stuart Mounter*, *Dr Nam Hoang*, *Aruni Gunawardena*, *Dr David Hadley* and *Jonathan Moss* all attending. Bligh presented the paper: 'The Governance of Grapes: The NSW Inquiry into Wine Grape Market and Prices: An Assessment', co-authored with Brian Dollery and Michael Kortt. Oscar presented a paper co-authored by Jonathan Moss titled "The Role of Abatement and Transaction Costs for Carbon Projects in the Land-use Change and Forestry Sector". David Hadley and Jonathan Moss exhibited posters. Nam presented his paper co-authored with *Dr Emilio Morales* on "Beef Marketing Margins in Australasia" and Aruni presented a paper from her PhD "Effects of Increasing Agricultural Productivity: A Computable General Equilibrium Analysis for Sri Lanka".

While in WA, Bligh also travelled north to interview the Director of Creative Communities at the City of Greater Geraldton, following international recognition of the City's community engagement strategy. This interview will be included in the Centre for Local Government's <u>Australian Local Government Voices Series</u>. As well as recognizing the financial support given by the School, Bligh would particularly like to thank Professor Jeff Gow of the University of Southern Queensland's School of Accounting Economics and Finance, for his responsible driving efforts over the course of the week.
