# Retirement of Associate Professor Jack Sinden

Friday 22<sup>nd</sup> July was Jack's last day of employment with UNE, after 43 years. During this time Jack maintained an outstanding record in teaching, a first-class record in research, and an exemplary record of service to the community and the University. Some highlights from Jack's career include:

- Jack's teaching achievements have been recognised by 2 UNE Teaching awards. Student evaluations have repeatedly rated him as an excellent teacher and he is renowned for enthusing students about agricultural and resource economics.
- Jack's research interests have focussed on the economic analysis of the use of land and natural resources to increase the sustainable welfare of the community. He was a leader in the debate regarding the effects of the Native Conservation Vegetation Act introduced by the NSW Government in 1998. His research demonstrated that the Act imposed a large cost on farmers and he was instrumental in achieving a revision of the Act.
- Jack has raised more than \$1.3m in competitive external research grants. He has published 3 books, 1 of which is widely adopted as a prescribed text in benefit-cost analysis in Australian and overseas universities. He has published 85 journal articles, including 31 on which he is the sole author, as well as numerous book chapters and conference papers.
- Jack's service to the University and the community has included Graduate Student Co-ordinator (Masters); contributing to state-wide policy formation on protecting native vegetation on farms; and chairing the national Industry Leadership Group for the Australia-wide *Horticulture for Tomorrow* project.

Happily, Jack will continue as an Adjunct Associate Professor in his current office. All the best for your 'retirement'!

# PRME Conference

Valerie Dalton attended the inaugural Australian Principles for Responsible Management Education (PRME) conference on Friday 22nd July in Sydney. The event was cohosted by UNSW and Griffith Universities and was attended by universities across Australia and New Zealand plus members of the Global Compact. Approximately half were already signatories. Around 14 Australian universities have already become signatories. There were approximately five when UNE signed in 2009.

The UN Global Compact (GC) is "a strategic policy initiative for businesses that are committed to aligning their operations and strategies with ten universally accepted principles in the areas of human rights, labour, environment and anti-corruption". PRME is the education initiative that sits alongside the GC.

Presentations and discussions centred around incorporating PRME into curriculum for universities and how signing to the GC can be incorporated into business activities. Reports from members of each group commented that the principles provided helpful frameworks for guiding activities.

In the case of curriculum, the guidelines indicated that it was necessary to incorporate elements of PRME across all units on offer and to run a specific unit that dealt with sustainability and ethics, which is the approach we have taken as a school.

The next conference will be held at Griffith University next year.

Our first Sharing in Progress Report is complete and awaiting signatures before being loaded onto the PRME web site.

# Malcolm Wegener to Present the 2011 Jack Makeham Memorial Lecture

## "Some reflections on 50 years of farm management in Australia" 3pm, 26 August, W42 Lecture Theatre 4

## Abstract:

Malcolm Wegener completed a Bachelor of Agricultural Science degree from The University of Queensland in 1963 having undertaken the available training in agricultural economics supported by a scholarship provided by the Queensland Department of Agriculture and Stock (later Primary Industries). In the late 1950s, the Department was strengthening its graduate workforce by offering scholarships to university entrants and recruiting cadets to meet the needs of Queensland's expanding agricultural industries. An Economic Services Branch had been established within its Division of Marketing to provide farm management advice to producers and service agriculture more broadly than supervise the many marketing boards and cooperatives that had been set up to handle, process, and market the state's agricultural commodities.

The Department's farm management research and advisory services in the 1960s were essentially divided between farm surveys and farm management accounting groups, the latter driven strongly by the personal background of the branch Director at the time, Elton O. Burns, a long serving public employee and trained accountant who later became Director-General of the Department and held other prominent positions of influence in Queensland's agriculture.

A fortuitous meeting at the IAAE Gold Coast conference in 2006 with a professor of accounting from the UK interested in the history of farm management accounting in Australia, led to an opportunity to revisit this topic and reflect on what was achieved by the large investment of public resources into farm management accounting and related activities including the establishment of the private farm management consulting profession in Australia in which Jack Makeham was a notable pioneer.

Mal will review these developments and consider some current issues in farm management brought about by the increasing prominence of successful large scale farming in Australia, the dominance of supermarkets in the supply chain for fresh food, widespread imports of food and agricultural produce, and international investment in our agricultural resources from the perspective of a professional career of over 40 years in applied agricultural economics research, practice, and education.

## Mal's profile:

Malcolm Wegener studied agricultural economics at The University of Queensland and after graduation worked for the Queensland Department of Primary Industries in Brisbane and Rockhampton, then moved to the Bureau of Sugar Experiment Stations because of his desire to work for the Queensland sugar industry. He received his PhD in the late 1980s for research involving application of a computer simulation model of sugarcane growth he helped to develop through collaborative research involving CSIRO, BSES, and the United States Department of Agriculture. He joined the University of Queensland in 1991, and taught farm management and production economics subjects, supervised postgraduate students, participated in two CRCs servicing the sugar industry, and consulted with sugar industries in Mauritius, Brazil, the United States, China, and India until retirement in 2006.

Since then, Mal has continued his involvement with the sugar industry with a focus on opportunities for the industry to contribute to renewable energy supply, provided short-term training in research methodologies to overseas postgraduate students, participated in international consulting engagements, and tried to run a small farm. The family property on which he was raised, and still lives, has been in the family for over 100 years but may soon succumb to the developer's bulldozer.


# Visiting Academic – Dr Ricardo Gonzalez

Dr. Gonzalez will be visiting UNE for one sabbatical semester (2-2011) to undertake research with Dr. Oscar Cacho and the Agricultural & Resource Economics team at BEPP.

This is a good opportunity to encourage collaboration of research between the University of La Frontera (UFRO), Temuco, Chile and UNE. Dr. Gonzalez is assistant professor of Natural Resource and Environmental Economics at UFRO and his research interests are on Land economics, Economic Models of Land-Use Change, and Evaluation of Policy instruments and programs using econometrics. Dr Gonzalez has experience in econometric modeling of land-use change and its policy and economic drivers. The main purpose of his visit is to provide UNE with skills in econometric analysis of land use and the expertise to assist with the development of computer tools to support the projects of Dr. Cacho and the team of Agricultural and Resource Economics.

During his stay Dr Gonzalez will give a presentation of his latest research on policy program, evaluation: 'Econometric modeling of land use changes in southern Chile' in the AARES / Agricultural and Resource Economics Seminar Series on Friday 5<sup>th</sup> August 2011.

# New Book Guides Students Through the Research Journey

A new book launched at the University of New England earlier this month is likely to become a "must have" for students considering postgraduate research.

UNE's Professor Ray Cooksey wrote *Surviving and Thriving in Postgraduate Research* together with Professor Gael McDonald from Deakin University. The book is published by Tilde University Press.

Designed specifically for Australian and New Zealand students, as well as for international students studying in Australasia, *Surviving and Thriving in Postgraduate Research* contains practical advice and a guide to resources in an accessible, plain-language style.

It helps the reader through the postgraduate research process and the planning and production of a thesis, and assists in addressing the challenges along the way. "The book focuses on the effective design and management of a postgraduate research project - from its inception and the commencement of a relationship with supervisors through to the submission and examination of the dissertation," the publishers say.

"We wrote the book to answer all those questions that emerge for students during their postgraduate research journey," Professor Cooksey said.

Ray Cooksey (pictured here), from UNE's School of Business, Economics and Public Policy, is also the author of *Illustrating Statistical Procedures: For business, behavioural and social science research* (Tilde University Press, 2007) and *Judgment Analysis: Theory, methods, and applications* (Academic Press, 1996).

Professor Annabelle Duncan, Deputy Vice-Chancellor (Research) at UNE, launched *Surviving and Thriving in Postgraduate Research* during the sixth annual Postgraduate Conference of UNE's Faculty of The Professions.

Professor Alison Sheridan, Head of the School of Business, Economics and Public Policy, said at the book launch that Professors Cooksey and McDonald had been presenters at the Australian and New Zealand Academy of Management's doctoral workshops for many years. She said that they had brought to the writing of their book "a breadth of experience, and the ability to connect with students, that makes *Surviving and Thriving in Postgraduate Research* a particularly valuable resource for all students embarking on their research careers".

# **BEPP Conference Travel Grant Reports**

Successful conference travel grant recipients report on their recent conference attendances.

Mona Abou Taleb presented in one of the prestigious conferences in Australia named "Accounting and Finance Association of Australia and New Zealand (AFAANZ) Conference". The conference was held from Sunday, 3 July – to Tuesday, 5 July 2011 at Darwin Convention Centre, Darwin, Australia.

This conference accepts only the highest quality papers which have innovative ideas as well as high academic writing quality style.

**Dr Nam Hoang** and his co-author Assistant Professor Eric Stuen (University of Idaho) presented the paper titled: "Malnutrition and Fertility: Evidence from Vietnam", at the 86th annual conference of WEAI, San Diego, July 2. The discussion of the paper was led by Professor Dang Tran, chair of the Economic Department, California State University - Los Angeles.

Dr. Nam Hoang was invited to give an econometric seminar at the University of Economics, Ho Chi Minh City on July 15 on the topic: "Recent Developments in Panel Data Time Series Techniques and Applications".

Dr Kamaljeet Sandhu attended and presented two research papers at the 6th Annual London Business Research Conference held at Imperial College of London, UK.

At the conference Dr. Sandhu was the Session Chair for five International high quality research papers.

Associate Professor Phil Simmons was a Plenary Speaker at the Third International Conference on Climate Change held in Rio de Janeiro on the 21st and 22nd of July. He spoke about the lessons from the nuclear accident at Chernobyl 25 years ago and how knowledge from that event is informing us about the Fukushima Daiichi accident. Phil's work in this area focuses on methodologies for assessing losses from nuclear accidents and the conference speech has been accepted for publication in the International Journal of Climate Change.

#### A Great Italian Experience: Pizza, Pasta, Wine and Productivity

**Dr Rene Villano** and **Professor Euan Fleming** attended the XII European Workshop on Efficiency and Productivity Analysis (EWEPA) held at the University of Verona, Verona Italy on the 21st to 25th of June 2011. Theoretical and empirical papers on productivity, production and efficiency measurement in economics, operations research, management science, industrial engineering, agriculture and related fields were presented in the conference. Rene chaired the session on efficiency analysis in agriculture and he also presented a paper on input mix efficiency and technology adoption in Philippine rice farming. Euan presented a paper on the decomposition of productivity measures in pig-based farming systems in United Kingdom. Feedback from the discussions for both presentations was very valuable. The conference also covered new developments in microeconomics and macroeconomics, including theory of production and growth, in a wide range of industries and public sectors.

Euan also attended one day of the American Association of Wine Economics (AAWE) conference held at the Free University of Bolzano, when **Dr Stuart Mounter** presented a paper for which they were joint authors. The papers presented in the conference sessions covered wine trade, supply chain and innovation, marketing and tourism, finance and wine markets and numerous case studies. The annual AAWE conference is gaining a reputation for critical and high quality research in wine economics. Some valuable insights were gained into the Italian wine industry that will benefit the content of a paper currently under preparation for journal submission.
