What we've been doing

- **Professor Brian Dollery** and **Bligh Grant**: The CLG has continued its research into two main areas. First, alternative methods of funding local government and addressing the infrastructure backlog in particular. This research has included several papers on the applicability of a municipal bond bank to Australia, with Professor Dollery delivering a paper at the Forum of Economists Conference, Amsterdam, 25 September on this topic. Second, CLG has been investigating community engagement as a technique of planning in Australian local government, completing a comparative overview of all Australian jurisdictions and a case study of Geraldton, Western Australia.

Livestock Demand and Supply Development: What's to Worry About?

3pm, 21 October, W42 Lecture Theatre 4

Abstract:

The livestock revolution that has occurred over the last few decades has seen a phenomenal increase in demand for livestock products in much of the developing world. This has largely been matched with growth in supplies, driven by government policies, and increased animal numbers and productivity. But this growth has given rise to a number of issues which in many cases see negative externalities imposed on society and suggest that current trends in animal product consumption and production are unsustainable. These issues will be discussed, along with possible research and policy responses.

Allan's profile:

Allan's early interests in horticulture took him to Massey University to study for a BHortSc degree which he completed in 1965. During that study, an interest in economics developed and this led to a MHortSc in horticultural economics in 1969, after a period as research officer for New Zealand's vegetable and produce growers' federation. Allan then left for the University of New England, where he completed a PhD in agricultural economics in 1971, and for which his thesis on stochastic programming won the D.H. Drummond Prize in Economic Studies.

Allan's academic career began with his appointment as a Senior Lecturer at Massey University, initially developing and teaching programmes in economics and management for students in horticulture. A few years later he was promoted to Reader, followed a few years after that with promotion to Professor in agricultural economics. Allan then developed his long-standing interest in international trade studies, became Director of Massey's Centre for Agricultural Policy Studies in 1985, and began a long involvement in international trade analysis, livestock economics and economics of Asian agriculture.

Allan has published many articles in leading agricultural economics journals, book chapters and has written two books: *Crop Management Economics* (1977) and *Agricultural Management Economics: Activity Analysis and Decision Making* (1994). He has conducted research for several international agencies.

Allan was awarded the New Zealand Science and Technology Medal 2001 by the Royal Society of NZ, became an Honorary Life Member of the NZ Agricultural & Resource Economics Society in 2009, was awarded the distinction of GTAP Research Fellow (2003-2010) by the Centre for Global Trade Analysis, Purdue University, and was conferred with the degree of Doctor of Science by Massey University in 2010.

He was a member of the Australian Agricultural & Resource Economics Society (AARES) Council during 2006-2008, served as AARES President in 2007 and was made an AARES Distinguished Fellow in 2010. Allan is currently Editor-in-Chief of the *Australian Journal of Agricultural & Resource Economics*.

UNE - NBN Seminar Series

On 29th August 2011, at Tamworth Resource Centre, the UNE – NBN Seminar Series focused on local government, the National Broadband Network (NBN) and development opportunities for innovative regional communities and universities of the future.

Pro Vice-Chancellor Professor Victor Minichello acted as Master of Ceremonies. Hon Tony Windsor spoke about what the NBN would mean for New England. UNE Vice-Chancellor and CEO Professor Barber, supported by Mr Darren Rudd, Community Relations Advisor NBN Co Ltd, described the opportunities for a university of the future in Tamworth.

The Forum keynote address was provided by Ian Tiley, Emeritus Mayor and Clarence Valley Councillor, Chairperson of Regional Development Australia Northern Rivers Board and a UNE Adjunct Research Fellow and member of the Executive Committee of UNE's Centre for Local Government. He provided a local government perspective on how the sector was preparing for, and considering, the National Broadband Network (NBN) rollout and how local government might capture the benefits of high speed broadband.

Ian noted that there has been substantial debate and conjecture within local government about what ought to be the role of local councils in regard to the NBN fibre rollout and community broadband take-up of the technology. He argued that there is much that local government could do in relation to the NBN planning process. Provision of information to NBN Co and its contractors, in the nature of zoning maps and planning controls, identifying heritage conservation and environmentally significant areas, advising development application requirements as necessary, locating of Commonwealth land and facilities and sites of major local development proposals or infrastructure locations and greenfield development areas, would all be important information and of value for NBN Co and communities.

Well developed community engagement plans by councils would demonstrate proactive leadership and explain the benefits of NBN services and also the impacts of the NBN build phase. He contended that it was important that councils communicate to all stakeholders in communities about how councils planned to support fibre rollout.

Ian highlighted that considerable economic benefits could derive to councils and communities given that, in some circumstances, local government would have the opportunity to engage in co-investment projects with NBN Co such as, for example, undergrounding of power, networks maintenance or upgrades, streetscape works, new bridges or road corridors and some land developments other than in greenfield sites. Fibre network extension may also be possible through third party proposals to extend the 'fibre footprint' beyond the intended 93% coverage, or to extend the fixed wireless coverage by co-funding additional infrastructure.

He presented evidence of initiatives of a number of local governments and his RDA Committee in preparing for broadband and engaging with their communities to explain and plan to capture the benefits. The NBN rollout was a project which many in local government and their communities now recognised would affect all aspects of the economy and society, and had the potential for Australia to become a global leader in terms of capacity and enjoyment of truly high speed carrier grade video, data and voice services. Ian concluded that there existed in communities an ever heightening expectation of an exciting, more productive knowledge based future. There was no doubt that local government must seriously engage. In many localities the sector was already playing a vital role at the local community coalface level to ensure that the benefits of broadband would be equitably and widely enjoyed.
